II. PUBLIC COMMENT

 Public Comment – Mike Cooper (County Commissioner's Office) conducted the statement of officer(s) and oaths of office for Anne Cano, Butch Miller and Dan Hejl. Mr. Cooper gave updates on the County's various roadway improvements and additions.

III. PRESENTATIONS

- 1. Fire Chief Report regarding facilities, apparatus and equipment, emergency operations, training, management activities, personnel matters, property tax, sales tax, intergovernmental relations, including written report. The county is currently under a burn ban. We purchased the three vehicles for the training and prevention offices. Chief would like the board to reconsider selling the inspector car. We will put this on the agenda for next month. In the process of getting clarification/confirmation that there may be a state administrative fee involved with getting the COVID vaccine for us.
- 2. Fire Marshal Report written report. We currently have seventy-four new/outstanding projects. We have plans on seven new apartment projects going on right now plus eight more that will be coming in. And twelve subdivisions under construction.
- 3. Hutto Professional Firefighters Association Report Held elections and Chris Mank is the new Vice President and Hannah Sartain is the secretary beginning January 1st. Levi Chuey will go into his second year as President. We recently presented a check to the National Fallen Firefighters Project for \$1,563 from the flag football fundraiser.
- 4. Hutto Volunteers and Explorers Report Currently have three volunteers. We are not currently accepting new applications due to the pandemic.
