Commissioner Hejl made a motion with a second by Commissioner Miller to approve the payment of \$125,499.06 for water and sewer fees required by Williamson County WSI&D District No. 3 c/o Crossroads Utility Services, LLC pending them revising their letter to ensure there will be no tap fees for the fire meter. Passed 4-0. Project is moving forward well. Slab should be poured in the next two weeks. Should have temporary power next week.
- 3. Discuss, consider, and take appropriate action on the administration building site and structure. It is with the City of Hutto Planning and Zoning. Just waiting to hear back from them. No action.
- 4. Discuss, consider, and take appropriate action on briefing statement #23.02-Lucas 3, v3.1 Chest Compression System. Commissioner Hejl made a motion with a second by Commissioner Miller to approve the capitol purchase of the Lucas 3, v3.1 Chest Compression System. Passed 4-0.
- 5. Discuss, consider, and take appropriate action on report from The Carlton Law Firm on 89<sup>th</sup> Legislative Session items. No report.
