It therefore requires Williamson County Emergency Services District #3 to be frugal with every penny of your tax dollars and manage your money in a very guarded manner. And Williamson County Emergency Services District #3 does this every day.

Williamson County Emergency Services District #3 is recognized across the State of Texas as a steward of the people's money. 





2021 PROPERTY TAXES IN WCESD #3





2020 PROPERTY TAXES IN WCESD #3





2019 PROPERTY TAXES IN WCESD #3





2018 PROPERTY TAXES IN WCESD #3




